Only by overcoming the divisiveness that is imposed upon us can we make our movement stronger

SUPPORT SPOKANE WORKERS



UNEMPLOYMENT FOR UNDOCUMENTED IMMIGRANTS

Job loss affects everyone, regardless of immigration status; the system that supports our communities shouldn't be based on immigration status either. The same system we all pay taxes into should help us when we need it most. Employers pay into the unemployment system on behalf of ALL workers, but workers who are undocumented are excluded from accessing the benefits they deserve. Next legislative session, our lawmakers must make sure that all working people, regardless of immigration status, are included in the benefits we pay into.

IMMIGRANT HEALTHCARE EXPANSION

Immigrants in our state have been systematically excluded from accessing basic preventative care and life-saving medical procedures due to their immigration status. The people who grow and process our food, build our homes, and provide direct essential services for us all deserve access to affordable health care that treats us with respect and that meets our needs. The new Apple Health expansion represents progress, the program is severely underfunded, and the work is far from complete. At best the current program funding will cover only about 12,000 people statewide - a tiny fraction of who will be eligible. Next legislative session, our lawmakers must expand immigrant healthcare to include ALL working and eligible immigrants in our state.

SUPPORT TULIP WORKERS IN SKAGIT COUNTY

Farmworkers are human beings that have the same needs, dreams, and hopes for the future of their families as everyone else. The beauty of the flowers is not enough; the rent must be paid and children must be fed. The 500 acres of tulips in Skagit Valley represent 75% of the US commercial tulip production. Farmworkers who grow 75% of a national industry do not deserve poor working conditions, low wages, and inadequate restrooms. Farmworkers whose labor brings 500,000 visitors to a community deserve compensation commensurate with the revenues of the industry for their contribution. Support tulip workers in Skagit Country through Community to community.

NO TO H2A

H2A is the modern day Bracero Program that exploits farm workers. The H-2A program allows agricultural employers to hire temporary foreign workers for jobs lasting up to ten months, contingent upon demonstrating an inability to find local workers. It has many flaws and has been compared to modern-day slavery. H-2A workers are tied to one employer, with their housing, food, and transportation tied to employment. One can get fired arbitrarily and deported at the whim of the employer. Growers prefer this control, citing labor shortages, while communities argue it displaces local workers, and drives down wages and worsens conditions for farmworkers because of the obstacles the H2A program poses to self organize and unionize.



CLIMATE ACTION NOW



The climate crisis is the most urgent issue of our time. We are also in the moment where we can take measures to mitigate. Workers that do the most important labor are the ones who are on the frontlines of the crisis but also the ones who can lead the change. In an economy that pits the climate versus the economy, labor is vital in creating an economy that is regenerative instead of the extractive one we currently live in. Immigrants who do some of the most dangerous work are often exposed to the most extremes of the changing climate. Often the decisions made about climate change are made without input from immigrants and impacted groups and that is why we must rally to build the power necessary to protect lives and the planet. Our local actions can uplift and contribute to the global climate justice movement.

CEASE FIRE

HOUSING IS UNAFFORDABLE AND UNATTAINABLE

Spokane is experiencing a major housing crisis. We lack affordable housing. The vacancy rate among affordable rentals is 2.0%, and the average Spokane home value is now at \$386,037. More than 1,245 men, women and children are homeless on any given night in Spokane County. We survived a pandemic but couldn't keep tenants safely housed in affordable homes. We need to balance the power between tenants and landlords. High rents affect almost all segments of the population but are an especially heavy burden for immigrants.



LANGUAGE ACCESS



Everyone deserves to speak in their language in their workplace as well as city and state agencies. EVERYONE should be able to safely say, "I don't understand, I need an interpreter". Over 40,000 people in Spokane County speak a language other than English at home in Spokane County, yet many people are unable to access basic services because of language barriers.
